All payments for season tickets must be made from the account holder's credit card or account holder's check or in person in cash by the account holder. Seating payments must be entered into the account with season tickets, while gifts can be made on behalf of another person (at donor's request). All season ticket purchases and donations must be received by May 1, 2020 to qualify for 2020-2021 benefits.
