Due to recently passed tax law, effective January 1, 2018, no portion of a priority seating payment is considered to be a charitable contribution and will no longer be 80 percent tax deductible. Please note, for the 2018-19 year, contributions made through priority seating will continue to count toward your Wildcat Club Annual Benefits Level, despite no longer being considered a tax-deductible gift. This is subject to change for subsequent years. Please consult your tax advisor if you have questions about your contributions to Arizona Athletics. All benefits may be declined with a written request at the time the gift is made. All benefits and giving levels are subject to change on an annual basis. All payments for tickets and/or priority seating must be made from the account holder's credit card or account holder's check or in person in cash by the account holder. Priority seating payments must be entered into the account with season tickets, while gifts can be made on behalf of another person (at donor's request).
